Ms. Melanie McConnell, Associate CAO, Corporate Services Division, confirmed the Public Hearing was advertised and notice was provided in accordance with the applicable legislation.

Ms. Sheera Bourassa, Planning and Development Officer summarized the purpose for the Public Hearing.

In accordance with the Public Hearing Procedures, Mayor Reutov went through the order of presentations as follows:

#### The applicant:

Ms. Anita Polturak, Manager, Family and Community Support Services, on behalf of Lac La Biche County presented on the Transitional Housing Project which would encompass four stages of development and cited that the current housing is no longer viable.

## Those in support of the proposed bylaw:

1. Ms. Lenora LeMay, Chair, Lakeland Out of the Elements Shelter Society presented that the Society in the last ten years, managed homelessness space in a constricted space but more needs to be done to end homelessness as managing is not enough. Ms. LeMay cited that a facility, and nearby services, would help in ending homelessness.

## Those opposed to the proposed bylaw:

1. Mr. Peter Watson, past President, Rotary Club of Lac La Biche expressed concerns about Council's decision to proceed with transitional housing at Alexander Hamilton Park, particularly about the park itself and impacts to the Rotary Disc Golf Course of which there is a signed sponsorship agreement with Lac La Biche County.

- 2. Ms. Susan Ward, President, Rotary Club of Lac La Biche shared that the Rotary Club's agreement was an opportunity to provide a safe and healthy recreation space for activities for all ages and that the currently location was ideal for the Rotary Disc Golf Course and complimented other Rotary Club initiatives such as the gazebo and exercise equipment located within the County. The Club recognizes the need for transitional housing; however, it is directly adjacent to the Rotary Disc Golf Course and would impact use of the course, in addition to safety concerns attributed to access to the proposed project.
- 3. Mr. Danny Stevens, presented on behalf of six residents of the Alexandra Renaissance Condo Association, citing that the land would be better suited for recreational purposes. Mr. Stevens mentioned the project would be determinantal to future projects, in addition to concerns about a lack of consultation and responses from Councillors. Mr. Stevens was also concerned that discussions about the project did not happen in open session. Mr. Stevens does not oppose the transitional housing project but is opposed to the rezoning of the land.
- 4. Mr. Colin Cote is in favour of the transitional housing project and recognizes that something has to be done but is not in favour of the location process selection or the rezoning. Mr. Cote referenced that Municipal Development Plan believing the intent was to protect the wetland and is thereby unsuitable for development. Mr. Cote spoke about project development and Council's 2022-2032 Strategic Plan & Goals, and that the selection of the location is only meeting one of the goals-Social Wellness at the cost of three goals-Economic Growth, Tourism and Recreation and Environment and Agriculture.
- 5. Mr. Omar Taha is an adjacent landowner and is directly impacted and is concerned that he wasn't notified of this development citing double standards due to a lack of consultation despite dirt work being done. Furthermore, he is concerned about being flooded due to the installation of a culvert. Mr. Taha shared that he has a property for sale that could be used for this project.
- 6. Mr. Jordan Gauthier, Dynasty Properties, presented his written submission.
- 7. Ms. McConnell also read the following two submissions-in opposition of the proposed bylaw, into record from the following:
